From the Dean

Dear friends,

I had a wonderful experience in May: I got to play a short recital on the Von Beckerath organ in Columbus' First Congregational Church. This was just a few weeks after our Organ Excursion, so I was eager for the opportunity. It was the first concert of the Heidelberg Concert Choir spring tour, and the pastor had invited me to play a prelude to their concert. It's always a challenge to play on a different instrument, but I enjoyed myself tremendously!

Our annual banquet on May 17 was delicious, from the spinach salad to the white chocolate bread pudding! Twenty-five of us attended, enjoying a showing of the AGO video production "Pulling Out All the Stops." If you haven't seen this yet, I recommend it highly. There are several segments, depicting the many ways pipe organs have functioned in the lives of our communities. Not only are church organs featured, but also concert instruments like the one in Methuen Memorial Concert Hall in Massachusetts and the Spreckels Organ Pavilion in San Diego's Balboa Park. There is footage of a Pipe Organ Experience, which allows the viewer to explore, along with the young participants, the inner workings of a large tracker organ. One of the segments tells the story of a church in North Carolina and their efforts to install a pipe organ after many years of dreaming, planning, and saving. We get to see step-by-step how the organ is built in the Holtkamp shop and then

installed in the church. The people's excitement at the dedicatory service actually brought a tear to my eye!

With the banquet we wrapped up our program year. I spent a few moments reflecting on this year and its several high points: our Progressive Dinner and Recital in September; the Jazz evening with Mark Mathias, Eric Dickey, and Mark Lemle; the student recital at Trinity downtown; the Halloween concert with silent movie, played by Aaron David Miller; and the Columbus Organ Excursion. Those were my high points, at any rate; what were yours?

On Saturday May 18, I attended the Ohio Deans' meeting at the Bunn & Minnick shop in Columbus. David Lamb, our Region V councillor, is an energetic promoter of all things AGO. There were folks around the table from most of the chapters in Ohio. As we shared our chapter events, I was proud of Toledo chapter's work, and pleased to pick up good ideas from others.

Looking ahead, the Executive Committee will be meeting on Monday, June 10, to begin planning next year's program. Board members are requested and strongly encouraged to attend!! 
I wish each of you a summer of relaxation and renewal. Take time to re-charge your batteries, learn some new music, work in your garden, sit in the sun. Enjoy!

- 3. Give them Pam Davis' contact info and help them to make the connection.



WE REMEMBER BILL ZOPFI

Chapter member Bill Zopfi passed away on Sunday, May 12, at Hospice of Northwest Ohio in Perrysburg. A Toledo native, he graduated from Central Catholic High School and then served in the Army from 1945-1947. Stationed in Seoul, Korea, he entertained the troops as a pianist with the 282nd Army Ground Forces Dance Band.

Bill was a talented musician – not only a church organist but also a theater and roller rink organist! He played at the Rollercade Rink in Toledo from 1948-1962. He was the first organist of St. Patrick of Heatherdowns Parish. If that was not enough, he also played piano at some of the finer nightclubs in Toledo. He was good friends with past cathedral choirmaster/organist, Hugh Murray, as well as many other Toledo organists of the time.

Bill moved to Cleveland in 1962 to play at the Palace Theater and was organist at St. Clement Church in Lakewood. For many years he performed at Baratko's Lounge in Lakewood and became lifelong friends of the proprietors, Gary and Lyn Baratko. Bill returned to Toledo in 1987 and in his retirement was organist at St. James Parish and a substitute at St. Charles and Rosary Cathedral, where he was a member. Later, he also played for Masses at the Little Sisters of the Poor Home in Oregon and the Ursuline Motherhouse in Toledo.

Bill and his mother, Helen, loved to travel and, before her death in 1988, visited many regions of the United States and Canada.

A Funeral Mass was celebrated on Friday, May 17, at Rosary Cathedral. A half hour prelude was played on the Skinner organ, which he loved to play and listen to. In the funeral homily, Msgr. William Kubacki, cathedral rector, spoke particularly of Bill's grateful attitude for all the gifts bestowed on him during his life and his many friends.



Position

ETHICS Revised by the National Council on April 16, 2007.

Preamble: The purpose of the American Guild of Organists is to promote the organ in its historic and evolving roles, to encourage excellence in the performance of organ and choral music, and to provide a forum for mutual support, inspiration, education, and certification of Guild members. Voting members are entitled to enjoy the privileges and are expected to accept the responsibilities of membership in the Guild. Members shall be considered equally for Guild offices and participation in Guild activities. These are the rules that shall be considered binding upon all voting members in good standing.

RULE 1. Members shall promote good working relationships within the American Guild of Organists and shall respect the employment of colleagues. Members shall address differences between themselves and other members by following the procedures outlined in the Discipline.

RULE 2. Members shall not seek or appear to be seeking employment for themselves, a student, or a colleague, in a position held by someone else. Members shall apply for employment only for a position which the employer, with the knowledge of the incumbent musician, has officially and publicly declared vacant by announcement of the vacancy.


RULE 3. In cases pending under the Procedures or in cases where the National Council has determined that a position has been made vacant by wrongful termination of a member of the American Guild of Organists, members shall not seek or accept regular or permanent employment for themselves, a student, or colleague at that Institution until the National Council is satisfied that differences between the Guild and the Institution have been resolved. Interim services may be provided for a period of 90 days.

RULE 4. Members shall obtain the approval of the incumbent musician before accepting an engagement for a wedding, funeral, or other service requested by a third party. In such cases, the incumbent should receive his/her customary fee, and the third party is expected to provide it. It is the responsibility of the guest member to inform the third party of this rule. Members are advised to protect themselves as incumbents in this regard by negotiating employment contracts which secure these fees and which provide some responsibility, oversight, and control as to choice of music, etc.

RULE 5. Members shall conduct professional activities with truthfulness, honesty and integrity, and shall maintain sensitivity in matters of a personal or confidential nature.

RULE 6. Members shall not discriminate against others on the basis of race, national origin, age, religious affiliation, gender, marital status, sexual orientation, disability, or medical condition (including, but not limited to, Acquired Immune Deficiency Syndrome).
